## Guidelines for submission of Research Papers:

- 1) The front page of the Research Paper shall include the Title of the Research Paper, Name of the Student, Class, Email-id and Mobile number. The content of the research paper shall strictly be in accordance with the theme of the competition.
- 2) The paper should be a 'Word File', having 'Times New Roman' as Font. The Font Size should be 14 for Titles, 12 for sub-titles, Body Text and Footnotes (font size 10). The paper should also have a margin of 1.5 inch on the left and 1 inch on the right and line spacing should be 1.5. Manuscript should not exceed 5 pages including graphs, tables and appendices.
- 3) The Full paper should not exceed 3500 words and shall contain Abstract, Introduction, Objectives, Statement of the Problem, Hypothesis, Methodology, Data Analysis, Suggestion, Conclusions and References. The paper shall be written by a single author or maximum two authors only,
- 4) All notes must be serially numbered and given at the bottom of the page as footnotes. References should be given at the end of the paper and should be as per the APA style. In case of website references, the entire URL should be provided.
- 5) Selected research papers will be allowed to be presented and students may present their paper through the help of PPTs.
- 6) Soft copy of research paper in word file along with Plagiarism report of less than 10% from Turnitin Software should be sent to email id: [researchdevelopmentclubkclc@gmail.com](mailto:researchdevelopmentclubkclc@gmail.com) alongwith PPT on/before 21st October 2024 by 02:00 PM
- 7) Students shall submit a Hard Copy of the research paper along with Plagiarism Report in college between 21st to 22nd October 2024 between 12noon to 1:00pm.
- 8) Each Author must register on the provided Registration Form Link <https://forms.gle/tbydaFX000rp8BsX9> individually in order for participating in the Conference.
