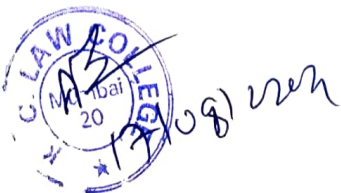
**Guidelines for Submission for written project/assignment for subjects:**
