

**2. Guidelines for Chamber Visit**

i. The word limit should be 500 to 700 words.

ii. Student should write their observation regarding document preparation and guidance received on client counselling.

i. The word limit should be 700 to 1000 words.

ii. Student should write their observation regarding civil and criminal cases.
