 - College identity card or fee receipt of first year and second year LL.B. (original and attested photocopy of each document)
 - Copy of online affidavit of Anti Ragging Form (i.e. https://antiragging.in/site/affidavits_registration_form.aspx)
 - Filled Undertaking (attached to this notice)
 - Caste Certificate and Caste Validity Certificate and Non-creamy Layer certificate for the reserve category students (if applicable)
 - Copy of Digital University form (whenever available on mum.digitaluniversity.ac) ****
3. Students are required to follow the steps given below for filling the college application form for third year LL. B admission for the A.Y. 2025-2026.
4. You shall receive an SMS for payment of fees only after the verification of the documents.
5. Admission will be confirmed only after the verification of documents and when you make the payment.

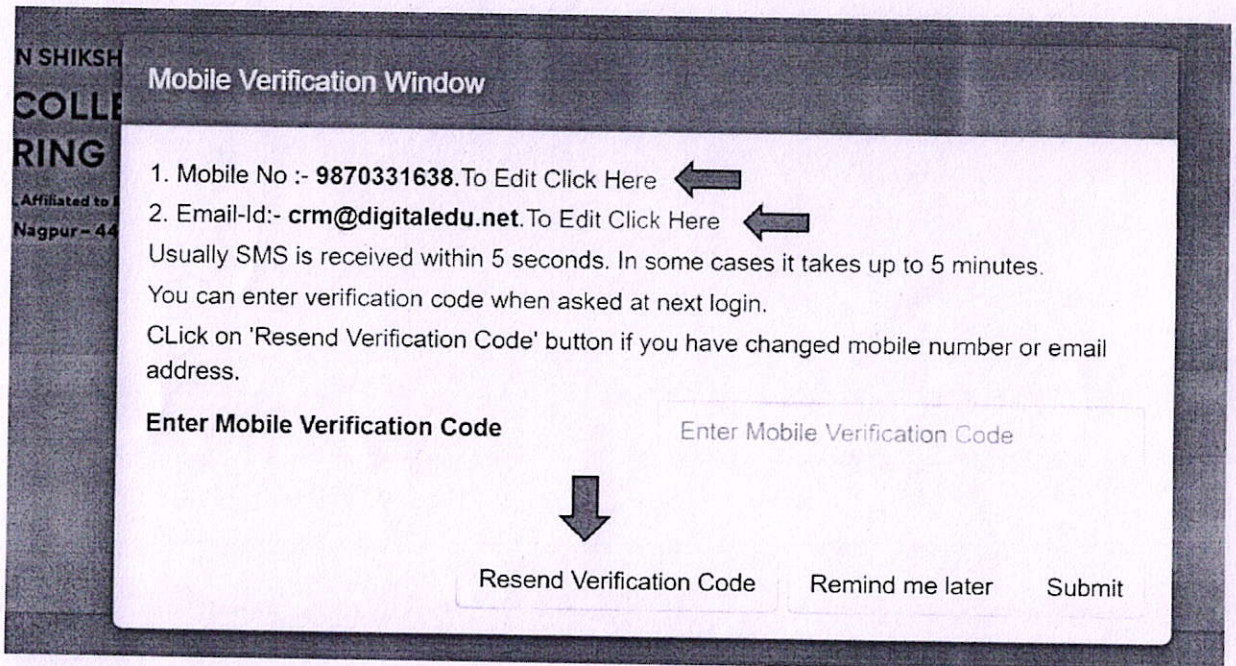

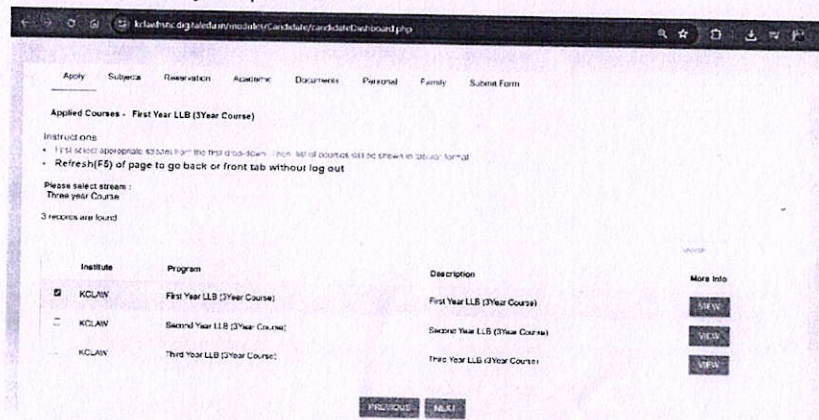
2) Contact details verification
