  10. Proper Certificate, declaration, etc. have to be duly signed and included in the dissertation. (Sample of the declaration & certificate is enclosed for reference).
  11. The date of viva voce for dissertation will be informed by the College through the notice.
  12. Students should submit the soft copy and two sets of hard copy of dissertation on **30<sup>th</sup> March 2024 at 02.00 p.m.**

**Journal/periodical Referred:** Name of author of the article, title of the essay within inverted commas, volume number of journal, Name of the journal in abbreviation & page number (year).

E.g. K. Madhusudhana Rao, "Authority to Recommend President's Rule under Article 356 of the Constitution", 46 JILI 125 (2004)

**News paper Articles Refereed:** Name of the writer, Title of the write-up within inverted commas, Name of the newspaper, date.

Robert I. Freidman, "India's Shame: Sexual Slavery and Political Corruption are Leading to an AIDS Catastrophe", The Nation, April 8, 1996.
